

Guidance in food packaging materials legislation

May 2022

Food packaging materials used in the European Union must comply with European food contact materials legislation. It differs per material whether material-specific legislation also applies in addition to general legislation.

In this document, the KIDV provides an overview of the applicable legislation in the European Union. This information can be used to map European legislation that applies to a specific material in three steps.


Step 1: Determine the type of material.

Step 3: See which requirements are included in the legislation.




Step 1 – Determine the type of material






Continuation of step 1 – type of material
